Covid-19 could not stop ESNA' 29th Annual Meeting! Not to be defeated, we held our annual meeting virtually on Facebook and all of our elected officials rallied to make the meeting a *zooming* success. If you missed it, watch it at https://www.facebook.com/esnanyc/videos/854020338678507
President Barry Schneider reminded everyone of how difficult these last eight months have been for us but most especially for our small businesses. That's why it is so important, he said, for all of us to frequent our local businesses, the restaurants and the local health care providers who need our patronage as never before. And that message also clearly came from our local elected officials and our guest speaker, Manhattan Borough President Gale Brewer.

In addition to calling for support for community businesses, Congresswoman Carolyn Maloney covered how important voting and participating at all levels of government is. State Senator Liz Krueger and State Assemblywoman Rebecca Seawright urged members to get behind plans they want to introduce to revamp the early



voting procedures which had been implemented for the first time in New York and which with huge delays did not go as smoothly as it should have. State Assemblymember Dan Quart and Councilmembers Ben Kallos and Keith Powers focused on the challenges created by Covid 19 –for parents and schools, for transit, for senior centers, for food banks and for all social service providers.

Gail Brewer continued saying that ESNA has always been at the forefront of advocating for quality of life in the East 60s but with the lingering coronavirus threats, government must now step in to go beyond quality of life issues to take on survival of life issues. While there is a wonderful working relationship between the 19th Precinct and the ESNA community, a herculean effort has to get underway citywide to have police and community working together. There is a need for creative ideas in utilizing empty hotels and for coming up with programs to compensate for cuts to the city's budget. These concepts, Borough President Brewer said, require community, real estate interests and government working together to find creative solutions. Upon closing her remarks, Barry Schneider presented her with ESNA's Community Spirit Award for her years of dedicated service to the community. Thanking him, the Borough President said that ESNA understands better than most what is needed to make a community - it is through citizen participation and collaboration efforts.

After dispensing with the business requirements of the annual meeting to elect directors and present financials, Barry went into everyone's anticipated segment of the meeting –The Map –with his description of what's going on in the neighborhood. (The Map accompanies this newsletter.) But the good things that go on in the neighborhood, he said, could not happen without the dedication of neighborhood volunteers like Will Sanchez who must be commended for his outstanding effort on behalf of the 2020 Census, tirelessly tracking down residents in building after building since an individual not counted is a loss of \$4,000 in federal funds to New York & \$7000 for a family of 2 or more. Barry also gave a special shout out to the health care workers in our community who have performed so heroically during the Covid-19 pandemic. In closing, Barry thanked everyone involved in making this virtual meeting a reality.
